NOTICE OF VACANCY OF SEVENTH DISTRICT ASSOCIATE JUDGE

TO: All applicants for Seventh District Associate Judge Vacancy

DATE: January 9, 2026

The Bar and public are hereby notified that a vacancy exists in the office of district associate judge for the Seventh Judicial Election District. The person appointed to fill this vacancy will be expected to carry out any assignment made by the Chief Judge of the Judicial District that is within the jurisdiction of a district associate judge.

Any interested and eligible attorney is encouraged to apply. To be considered by the Judicial Nominating Commission, the original completed application must be delivered or emailed to the District Court Administrator at Andrea.Dosland@iowacourts.gov no later than 4:00 p.m. on January 23, 2026, and a copy sent to each Commissioner at the email addresses listed by the same date and time.

No application will be accepted after 4:00 p.m. on January 23, 2026, regardless of the reason. Any application, together with supporting documents and letters of support, must be emailed to the Commissioners at the email addresses listed.

Applicants for the position must be members of the Iowa Bar, and a nominee must be a resident of the Seventh Judicial Election District or of a county contiguous to the Seventh Judicial Election District. A district associate judge must be a resident of the Seventh Judicial Election District or of a county contiguous to the Seventh Judicial Election District before assuming office and during the entire term of office. Applicants must also be of an age that will allow them to complete **the initial** term of office before reaching age seventy-eight. The present salary for the position is \$151,208.00.

The Seventh Judicial Nominating Commission has set January 27, 2026, as the date for a meeting at which applicants for the position will be interviewed by the Commission. All valid applications which meet the statutory requirements will be considered. However, if there are more applicants than can be effectively interviewed, the Commission may elect to screen the applicants and interview less than all. Applicant interviews shall be open to the public. The public will be allowed to observe and listen but not interact. Commission deliberations and voting will not be open to the public.

Following the interviews, the Commission will, in all probability, proceed by ballot to nominate two applicants for the position. The interviews and balloting will take place at the Scott County Courthouse, 400 W. 45th Street, Davenport, IA 52801. The names of the two nominees will then be sent to the Governor, who has 30 days within which to appoint one of the two nominees to fill the vacancy.

The person appointed to the position will serve an initial term of one year after appointment and until January 1 following the next judicial election after expiration of such year. The regular term of office of a district associate judge retained at a judicial election is six years from the expiration of the initial or previous regular term. Retirement of a district associate judge in Iowa is mandatory at age seventy-eight.

There is no requirement for applicants to individually interview with the Commissioners, nor is there a requirement for applicants to obtain letters of support. It is up to each individual Commissioner to determine whether or not he or she will schedule personal interviews with applicants; however, the individual policy of a Commissioner in this regard is to be applied consistently to all applicants who request an interview in a timely manner.

To facilitate any personal contact with a Commissioner which an applicant may wish to make, a complete list of names and email addresses of the Commissioners is provided below.

Prior to the interviews, the public will be permitted to submit comments or recommendations regarding the qualifications of an applicant to the District Court Administrator's Office at the following address: Court Administration, 400 W. 4th Street, Davenport, IA 52801 or by emailing Andrea.Dosland@iowacourt.gov. Comments and recommendations must be received by January 26, 2026 at 4:00 p.m.
