

## NOTICE OF JUDICIAL VACANCY

The Bar and public are hereby notified that Governor Kim Reynolds hereby serves notice of an upcoming vacancy in a district associate court judge position in Judicial Sub-District 2B. This vacancy will arise due to the upcoming retirement of District Associate Judge Kim Riley.

The Judicial Sub-District Nominating Commission for 2B met on Monday, September 19, 2022 to outline procedures and timelines to fill the vacancy. Applications will be accepted from Thursday, September 22, 2022 until Friday, October 21, 2022 at 4:00 PM. Any interested and eligible attorney (as defined by Sections 1 and 7 of 2022 Iowa Acts chapter 1033) is encouraged to apply. The public and Bar are encouraged to submit their opinions of any applicant.

The district associate court judge will cover associate level criminal matters, juvenile cases, possibly magistrate level cases and other case work as assigned by the Chief Judge. Counties of coverage will be assigned once a domicile is determined.
